This programme is suitable for people learning about workplace health and safety for the first time, and for more experienced practitioners who want to learn about best practice.

## RECOGNITION OF PRIOR LEARNING

Pro+Med (NZ) Ltd recognises prior learning and will help you, on application, to gain recognition for skills you may already have.

**Recognition of Prior Learning (RPL)** - processes for assessing relevant, current skills and knowledge gained from previous study and learning. There are three types of credit – cross credit, credit transfer and assessment of prior learning.

**Cross credit** – formal learning which has already been assessed and credited from another qualification, possibly by another accredited training provider and the applicant seeks credit towards a different qualification.

**Credit transfer** – formal learning when the equivalent/same paper or unit standard is used in two qualifications.

**Assessment of prior learning (APL)** – a process used to identify, assess and recognise current skills and knowledge that are not necessarily supported by formal qualifications. This assessment will be made using different forms of evidence and may include portfolio of evidence, written and/or oral challenge assessments and observation of practice .

Graduates will be awarded the New Zealand Certificate in Workplace Health and Safety Practice (Level 4)

Graduates of this qualification will have the workplace health and safety knowledge and skills applicable to job roles such as health and safety coordinators.
